Restoring Trust: The State of Intergroup Relations in North America

Trust between communities is under pressure across North America. Polarization, social fragmentation, economic anxiety, misinformation, and declining confidence in institutions are reshaping how people perceive one another and their societies. Yet the dynamics of intergroup relations differ significantly between Canada and the United States.

This plenary will examine the current state of cohesion and intergroup trust through a comparative Canada–U.S. lens. Drawing on public opinion data, demographic trends, social research, and institutional indicators, the discussion will explore how citizens perceive one another across lines of ethnicity, language, religion, region, race, and political identity. Panelists will assess what surveys and social indicators reveal about social distance, belonging, polarization, discrimination and national identity.

The session will also consider where Canada's model for managing relations is succeeding or faltering, how the U.S. experience differs, and what lessons both countries may offer in addressing division and rebuilding trust. Special attention will be given to evolving relationships between Indigenous and non-Indigenous peoples, French- and English-speaking communities, regional tensions, and the broader challenge of maintaining cohesion in increasingly diverse societies.

Rétablir la confiance : l'état des relations intergroupes en Amérique du Nord

La confiance entre les communautés est mise à rude épreuve partout en Amérique du Nord. La polarisation, la fragmentation sociale, l'inquiétude économique, la désinformation et la perte de confiance dans les institutions redéfinissent la façon dont les gens se perçoivent les uns les autres et perçoivent leurs sociétés. Pourtant, la dynamique des relations intergroupes diffère considérablement entre le Canada et les États-Unis.

Cette séance plénière examinera l'état actuel de la cohésion et de la confiance intergroupes à travers un prisme comparatif entre le Canada et les États-Unis. En s'appuyant sur des données d'opinion publique, des tendances démographiques, des recherches sociales et des indicateurs institutionnels, la discussion explorera la façon dont les citoyens se perçoivent les uns les autres au-delà des clivages ethniques, linguistiques, religieux, régionaux, raciaux et d'identité politique. Les panélistes évalueront ce que les sondages et les indicateurs sociaux révèlent au sujet de la distance sociale, du sentiment d'appartenance, de la polarisation, de la discrimination et de l'identité nationale.

La séance examinera également les points forts et les faiblesses du modèle canadien de gestion des relations, en quoi l'expérience américaine diffère, et quelles leçons les deux pays peuvent offrir pour surmonter les divisions et rétablir la confiance. Une attention particulière sera accordée à l'évolution des relations entre les peuples autochtones et non autochtones, aux communautés francophones et anglophones, aux tensions régionales, ainsi qu'au défi plus large que représente le maintien de la cohésion dans des sociétés de plus en plus diversifiées.

Global Network Learning and Simulation as tools for providing Affirming Care for 2S LGBTQIA+ Communities (EN)

This qualitative study examined how a Sexual Orientation and Gender Identity virtual simulation influenced nursing students' understanding of prejudice, inclusivity, and affirming care for 2S LGBTQIA+ communities. Challenges to Unity, Belonging, and the Canadian Experience

Taking place just days after Quebec's provincial election and Alberta's October 19 referenda, this plenary offers a timely opportunity to reflect on what these developments may reveal about the future of Canada and the evolving state of the federation.

Bringing together voices from across the country, the session will explore how Canadians experience identity, coexistence, and belonging in an era marked by political polarization, regional tensions, demographic change, and competing visions of the country's future. Through dialogue and reflection, speakers will examine several defining relationships within Canada: Indigenous and non-Indigenous peoples; Quebec, Alberta, and the rest of Canada; French- and English-speaking communities; and the continuing evolution of multiculturalism and pluralism.

The discussion will consider how recent political developments intersect with broader debates about federalism, autonomy, citizenship, and shared values, while asking whether a common Canadian narrative remains capable of sustaining solidarity and democratic life in a diverse federation.
