Changing the Narrative in Canada and the US: A Conversation Around Advocacy and Impact in the Immigration Space

For the first time in a quarter century, a clear majority of Canadians now say there is too much immigration. Public support for immigration has been grounded in large part in the belief that it contributes to Canada's economy. The Canadian government has created a powerful narrative that highly skilled, economically self-sufficient immigrants are the ideal candidates for Canadian citizenship. Sadly, refugees, and especially refugees from the Horn of Africa, do not fit that narrative. My presentation will summarize my ongoing research on the education and career aspirations of youth with refugee backgrounds from Eritrea, Ethiopia, Somalia, Sudan, and South Sudan. Instead of putting the structures in place that value the youths' assets and strengths, my findings consistently suggest that unexamined deficit thinking around race and refugees is used to sustain and produce new forms of everyday precarity for these youth. However, the youth are not passive bystanders. They are demonstrating they are capable and able to contribute meaningfully to their communities. Whether consciously or unconsciously, effectively or not, the youth are continuously pushing back on the common narrative that African refugees are needy and lack skills. They have adopted the counter narrative of capability, agency, and resistance.

Bridging Borders: Labour Mobility, Policy Shifts, and the Future of Immigration in North America

In recent years, immigration has become an increasingly complex and polarizing issue across North America. Both Canada and the United States have experienced a reduction in immigration numbers and faced growing anti-immigrant sentiment. Meanwhile, labour mobility has emerged as a critical issue, as economies on both sides of the border confront skills shortages and shifting demographics. This panel will bring together thought leaders and policy experts from Canada and the United States to examine these trends, assess their implications for the labor market, and discuss policy responses and practical solutions to foster inclusive and sustainable labour mobility.

This session will be co-led by Skills for Change, a Canadian organization known for its work in newcomer integration and workforce development, and the National Immigration Forum, a prominent U.S. organization advocating for the value of immigrants. This transnational dialogue will highlight both shared and divergent experiences and explore how policy and public opinion are shaping the future of immigration and labor markets across North America.

Operation Ukrainian Safe Haven

The session will focus on Canada's humanitarian response frameworks, focusing on the formal and informal partnerships between the federal government and the settlement sector. The session will highlight the benefits of this integrated response system, the information pathways present within the collaborative tables, and how this system supported the successful settlement of more than 200,000 displaced Ukrainians and 50,000 Afghan refugees. The session will also focus on lessons learned from Canada's Operation Ukrainian Safe Haven (OUSH), Afghan Special Initiative (AFI), and Operation Syrian Refugee (OSR), and provide recommendations that will guide Canada's future Humanitarian Response Framework and can be implemented locally.

Looking beyond the national: Regional leadership as a source of innovation

Conversations around immigration policies generally focus on the national level, and yet there are vast differences in immigration patterns, needs, and politics across regions in the US and Canada. Organized Crime and Migration in the Americas

Research by the North and Central American Task Force on Migration clearly outlined the need for new regional cooperation efforts to address migration and forced displacement in the Americas. Regional Migration Governance in the Americas: Challenges and Opportunities

As the Americas are witnessing substantial mobility, the institutional landscape of migration governance is complex with a rich history of sub-regional cooperation. This paved the way for the adoption of the Los Angeles Declaration on Migration and Protection on the margins of the 9th Summit of the Americas in 2022. This initiative holds great potential, but there are still

challenges regarding sufficient coordination and complementarity and integrating the established collaborations into the framework of the Declaration. This roundtable aims to review challenges and opportunities as this new mechanism emerges towards enhanced cooperation and synergy to improve migration in the Western Hemisphere.
